



The primary focus of the Parade of Lights, as part of the Night of Lights celebration, is to provide a safe, enjoyable, and quality parade on the streets of Downtown Jasper. There is a **\$10.00 fee to participate** in the Parade of Lights and must accompany parade paperwork to receive a position in the lineup. This fee allows us to provide awards for parade winners.

**PLEASE READ ALL RULES AND REGULATIONS**

**Parade Rules:**

1. **All Vehicles and Floats must be in place by 4:30 PM; Walkers and Animals by 5:00 PM.**
2. **Parade application must be completed and returned by November 24, 2017**
3. Driver of any motorized vehicle must have a valid driver's license and be 18 years or older. No skateboards or razor scooters.
4. **For safety reasons, CANDY and OTHER ITEMS MAY NOT BE THROWN FROM VEHICLES OR FLOATS. Participants are asked to provide walkers to give out CANDY and OTHER ITEMS.**
5. All applications are subject to approval by the JMA Board of Directors. You will be notified only if your application is rejected.
6. No Santa Suits allowed. Santa and Mrs. Claus will be the last entry in the parade to greet the children. **JMA reserves the right to have the only SANTA.**
7. Individuals and organizations are expected to perform courteously, in good taste, and with safety in mind at all times during the parade.
8. All parade entries are encouraged to follow and display the parade theme: **'Candyland'**
9. If the unit has animals in it, you **MUST** provide waste cleanup.
10. Anyone wishing to have **HORSES/PONIES** in the parade must have **Negative Coggins Documentation** returned with paperwork. **DOGS or OTHER SMALL ANIMALS** must have a current **Rabies Vaccination**.
11. Any deviations to these rules have to be approved by the JMA Board of Directors.
12. A copy of these rules signed must be attached to the signed application.  
**Applicant must agree in writing to abide by the disclaimer below.**

**Additional Note:** No applications will be accepted after November 24, 2017. Only valid (on time and paid) entries will be listed in the KnowPickens.com youtube video **Night of Lights 2017 Program**.


